FFA Membership Report

Johnson presented the membership report. Iowa has 4,739 members entered on the AgCN state web, still working on problems with entering students within the program.

IAAE Report

Bloom was not in attendance.

Alumni Report

Schmidt discussed the State Alumni Conference being held on Saturday, January 21, 2012 cost is \$15/person, starts at 9 with registration at 8. They will be having a silent and live auction. DeWitt Central FFA Alumni will be serving the meal.

Foundation Report

Remington discussed the current foundation planning for state leadership conference. The foundation is still finding CDE's sponsors. Remington also shared that they now have four major sponsors for state leadership conference. All four sponsors are now \$10,000 a piece for 2012 compared to \$8,000 in 2011. New software is being developed and will be launched in foundation soon and will say how each person was involved with FFA or how much money was previously given. Michelle McBride has been hired and is working currently in the financial department. A new administrative assistant will be hired in the next few weeks.

FFA Report

Smith reported about the state officers' FFA happenings. The state officers attended National FFA Convention, held Greenhand Fire-ups as well as 212/360 conferences, winter retreat, state leadership conference practices, and 36 chapter visits in the first semester.

Iowa State Fair

Meggers was not in attendance.

Postsecondary Report

Paulsen discussed the suggestion of 3.0 GPA requirement for Agriculture Education certification. Paulsen shared statistics of previous Agriculture Education students.

Non-Action Items

Global Compassion Network Proposal

Sioux Central FFA members presented a proposal to take part in the Global Compassion Network. The members explained it is a partnership with Sukup in building "SafeThomes" for people in Hati. The members explained the different phases in their planning of this project. Phase one would be to send FFA members to Hati for 10 days which would cost \$1,250.00 and training of foreign cultures. Phase two consists of challenging Iowa FFA with building three homes per district. The homes would cost \$5,700.00 and \$500.00 extra for a concrete floor as well as \$700.00 shipping. Sioux Central proposed to kick off this challenge at State Leadership Conference with a video in the first and fourth sessions. Dennis Anderson, whom was a clergy representative, then discussed his thoughts on the project. The board then discussed funding and who would be in charge of this project.

FFA Credit Card

Johnson discussed the \$10,000.00 spending limit for the association credit card. The president is going to continue to have a credit card. Johnson is looking into getting a business rewards card which costs \$50.00 a year, but the rewards should easily cover the cost. The board discussed the current \$4,000.00 spending limit on the State President's credit card what it should be in the future. Johnson is going to check with Michelle on past transactions decide the limit from there. Johnson suggested \$1,000 to \$1,500 spending limit.

CDE Personnel

Johnson reported that no improvement has been made since last meeting and nothing will probably happen before March either because of State Leadership Conference planning.

FFA Board Meeting Agenda Organization/Advance Notice

Johnson proposed to have a generalized due date for board agenda and board meeting minutes to be sent out. Board meeting agenda will be sent out one week before the meeting and minutes will be sent out one week after the meeting.

FFA Enrichment Center Lodging Form

Gruis reported that he hasn't talked to any of the attorneys yet due to bad timing. Johnson added that he thinks we need to have a contract written up and ready to present so that officers can stay at the enrichment center without a supervisor. Johnson hopes to have an email update out before the March meeting. Dodd offered to talk to a local Iowa Falls attorney.

Membership Roster Submission

Johnson discussed the concern with the membership submission. The board discussed what to do for upcoming events such as sub districts and district review night. Brockshus moved to suspend the rules that states that chapters must have completed their annual report, program of activities, submitted membership roster, and paid their membership dues. Technology: FFA Server at the Enrichment Center

Johnson reported that the association needs one server to store all files on. The board discussed the possibilities of getting a carbonate storage device which is \$229 a year. The board moved to appoint a research committee to check on a storage device. The committee consists of: Brockshus, Gaul, Mardeson, and Johnson, whom all volunteered. Middle School FFA at State Fair

Livestock CDE Date

Lutz called Jon Declerck in regards to whether switching the date would be possible. The board will vote over email if necessary.

Vet Tech CDE

Gruis discussed his conference in Indianapolis. National FFA is allowing each state to bring two teams to nationals this upcoming year. Dodd moved to have the student board under the direction of Gruis and Johnson decide the process. Blair seconded. Motion passed. Brockshus moved to concur. Smith seconded the motion. Motion passed.

Hiring Staff Coordination and Management of Services

Johnson discussed having Amber Heinrich, Irv Meier, Randy Dreher, and Sarah King be paid for their assistance to the association. All positions will qualify for Federal Perkins Funding, which the Iowa FFA Association has a small surplus of due to having no Executive Secretary for five months. Diedrich moved to pay Amber Heinrich \$2,500.00 for her assistance to the association. Worden seconded. Motion passed. Schmidt moved to concur. Lutz seconded. Motion passed. Patterson moved to pay Irv Meier \$2,500.00 for his work in career development events. Smith seconded. Motion passed. Dodd moved to concur. Russ seconded. Motion passed. Smith moved to pay Randy Dreher \$750.00 for state officer training. Patterson seconded. Motion passed. Blair moved to concur. Lutz seconded. Motion passed. Patterson moved to pay Sarah King \$500.00 to scan official FFA historical documents and reports. Worden seconded. Motion passed. Putz moved to concur. Dodd seconded. Motion passed.
