Executive Secretary Evaluation

Middle School FFA SAE Records

Gruis discussed management of middle school FFA members as a result of more questions he is receiving about SAE records, particularly for members that can show.

State Convention Update

Johnson explained that youth on campus cannot be un-supervised at state convention. Meals From The Heartland will continue this year with the potential option for FFA Chapters to take meals back to their home area.

Business & Industry Representative on the Board (Ex-Officio)

The 2010 restructuring of the board included an ex-officio position from business and industry to serve three-year terms starting in 2011. We currently do not have such an individual on the board. Any suggestions should be sent to Johnson.

State Officer Selection Process

Brockshus explained the changes to the state officer selection process that were included in the board packet. Discussion ensued about when to announce the officer ballot and it was decided to continue to announce it during the business session. Vet Science CDE

Johnson and Gruis explained that in January 2012, the board approved having a pilot Vet Science CDE. It is up to the board to approve Vet Science as an official State CDE beginning this year. Earll moved to approve the Vet Science CDE as an Iowa FFA event and Dolch seconded. Motion carried. Gaul moved to concur and Putz seconded. Motion passed.

Iowa FFA Constitutional Amendments

Johnson explained that the constitution should include language for the Discovery Degree since Iowa FFA allows for middle school membership. If approved by the board, the amendment

would be announced at the district conventions. Zumbach moved to propose the amendment and Earll seconded. Motion carried. Blair moved to concur and Putz seconded. Motion passed.

State Staff Authority to Grant Good Standing

Johnson explained that the board could give authority to approve chapters to state staff to reduce the necessity for board action each time a chapter past due completes the requirements. Fitzgerald moved to grant state staff permission and Galm seconded. Blair moved to concur and Putz seconded. Motion passed.
